Be Ready: 5 Commonly Overlooked Emergency Must-Haves for Vehicles

1) Cat Litter

Litter can also be used as a method of getting traction for your tires on slippery roads.

2) A Blanket

Keeping a blanket in your vehicle is critical if you live in cold climates or remote areas. Depending on weather conditions during the event of a roadside emergency, help could be hours away. Without a source of warmth, you could be in serious danger under such conditions. The best way to stay warm no matter what happens is to simply keep a thick blanket or two in your car at all times.

3) Shovel

A few minutes of digging can save you hours of waiting for roadside assistance. There are now many compact shovels made specifically for easy stowing in vehicles, which make for a great investment into your personal safety as you travel.

4) Fire Extinguisher


A small fire extinguisher is a must-have for every vehicle, as vehicle fires are more common than many people realize. Of all the emergency calls received by fire departments in the United States, about 13 percent are for vehicle fires. Putting out a vehicle fire quickly is extremely important because of the presence of highly flammable fuel, and a fire extinguisher is the perfect way to do just that.

5) Hazard Markers

The side of the road is a dangerous place to be. The more clearly other drivers can see

your disabled vehicle as they approach it, the earlier they can adjust their speed and create some space between them and your vehicle. Hazard markers are the best way to let any approaching drivers know your vehicle is not operating, so be sure to keep at least one marker in your vehicle, placing the marker a proper distance behind your vehicle in the event of an emergency.
